### 1. Approval of the February 2023 LAAS General Meeting notes

- Jessica Gambling asked all members in attendance to vote "yes" (approve) or "no" (don't approve) using the Zoom Chat feature.
- Notes were approved as written.

#### 3. Reminder on meeting recordings and meeting notes

- Notes are taken at every meeting by the Secretary.
- Zoom Chat is saved by the Secretary only for completion of the meeting notes. After which the Zoom Chat file is deleted.
- A draft copy of the notes are sent out ahead of meetings for members to review and offer corrections.
- Corrections should be sent directly to the Secretary and/or the Executive Committee.
- Meetings are generally not recorded.
- Occasionally, we will record select presentations so that they can be made available to members to view beyond the meeting.
- One member asked why we don't record the meetings? Executive Committee responded it was important to keep the meetings informal and candid; a dynamic which could change if the meeting were recorded.
- The same member still thought we should record the meetings. Further discussion ensued which covered:
  - Recording further complicates things because permissions are needed.
  - File space is also needed to store large files for each meeting if it were recorded.

- Another member brought up Zoom's functionality in terms of recordings: audio as well as video.
- A member mentioned in Chat that the meeting notes are a good summary of each meeting.
- Members in attendance were asked to vote on recording the meetings via the Zoom Chat feature. 14 voted against recording; 3 voted in favor of recording; and 7 voted "neutral."
